Registration Fee

I acknowledge and agree that the \$325 registration fee is non-refundable and is required to be paid in full at the time of submitting this application to secure my child's enrollment. **Initial** _____

Supply Fee

I acknowledge and agree that a \$175 supply fee per child will be added to the final tuition installment due on August 15, 2026, and that this fee is non-refundable. Furthermore, I understand and agree that if I have arranged an alternative payment schedule with the Director, the \$175 supply fee will remain due in full by August 15, 2026, or immediately upon enrollment if such enrollment occurs after that date.

Tuition Installments & Due Dates

I acknowledge and agree that the timely payment of tuition installments is a mandatory condition for my child's continued enrollment in Banner Preschool programs. I agree to pay my child's full tuition in three installments, with payments due on February 15, 2026, May 15, 2026, and August 15, 2026. I understand and accept that all tuition payments are non-refundable. **Initial** _____

Furthermore, I acknowledge that Banner Preschool reserves the right, at its sole discretion, to terminate my child's enrollment in the event that payments are not made by the specified due dates and no alternative payment schedule has been formally arranged and approved by the Director. **Initial** _____

Withdraw and Refund Policy

I acknowledge and agree that if I choose to withdraw my child from any Banner Preschool program for any reason, I may be held responsible for the payment of the full year's tuition, and I will not be entitled to a full or partial tuition refund. I understand that any consideration for a refund will be solely at the discretion of Banner Preschool and will only be evaluated if the program from which my child is withdrawn is at full capacity and the resulting vacancy is filled. In such cases, any refund issued will apply only to the time period after my child's vacated spot is filled. **Initial** _____

Furthermore, I acknowledge that to be eligible for any refund under these terms, I must provide written notice to the Director of my intent to withdraw my child by March 15, 2026. If notice is not received by this date, I agree to pay the full year's tuition regardless of my child's attendance. **Initial** _____

Screening and Evaluation Clause

I acknowledge and agree that the Executive Director reserves the right to determine whether the program is able to meet the full range of their child's educational or developmental needs. If, at any time, the Director believes that the child may require additional support or services beyond what the program can provide, I agree to cooperate with any necessary screening, evaluation, or assessment procedures, including but not limited to developmental assessments, academic screenings, or psychological evaluations, that may be recommended or required. **Initial** _____

Furthermore, I agree to adhere to any guidelines or recommendations set forth by the Director, including securing any external services or accommodations deemed necessary to support the child's educational or developmental progress. Failure to comply with such guidelines may result in the child's continued participation in the program being reviewed or reassessed. **Initial** _____
